Policy Prohibiting Shark Finning

禁止割取鲨鱼鳍的政策

Shark finning is defined as the removal and retention of shark fins and discarding the carcass at sea. Most shark species are highly susceptible to overfishing, and many are considered threatened or endangered. Furthermore, the wasteful practice of shark finning contravenes many international rules and regulations, including those of all major tuna regional fisheries management organizations (RFMOs).
